Dear Friends,

As we begin a new year, we are grateful for the many hands, hearts and minds that it takes to effectively run this organization and meet our mission. SAWs ended 2019 in a position of strength and continues

to be on a growth trajectory with no end in sight. We anticipate exciting changes in 2020 including hiring our first Operations Manager to oversee the work in our warehouse and manage an ever-increasing schedule of builds throughout Indiana.

We are hosting our first organization-wide Leadership Summit in February during which we will focus on standardizing safety procedures and best practices at every build site. It will be wonderful to welcome leaders from across Indiana as well as Arizona and Virginia to share and learn from one another. Having wrapped up last season with 372 completed ramps, we have a lot to celebrate as we lay the foundation for the path forward.

In addition to increasing the number of ramps we built last year, we also substantially increased the number of businesses that support SAWs. As word spreads about our Corporate Team Build opportunities and as business leaders experience it for themselves, we continue to receive more requests. Churches also substantially increased their support for SAWs in 2019. Both new and seasoned volunteers continue to find it to be a worthwhile and memorable experience to help someone gain their freedom.

Required Minimum Distributions (RMDs)

Required minimum distributions are withdrawals that the IRS requires you to take from your retirement accounts upon reaching the age of 72 (new in 2020). In IRAs, 401(k)s and similar accounts, no tax is due until you start making withdrawals. However, when you contribute directly from the custodian of your IRA to a nonprofit organization like SAWs, this gift is considered a qualified charitable distribution and therefore does not increase your taxable income.

Servants at Work Happenings in the Hubs

TIPPECANOE

SAWs has been building wheelchair ramps in Tippecanoe County area for almost 11 years. It all began when John Hunter, a SAWs volunteer who works at Subaru of Indiana Automotive, stepped forward. John found it convenient to do site evaluations, prefabrication and construction after work and recruited fellow workers from the plant to volunteer with him.

Over the years, our efforts in Lafayette have been enhanced by a partnership with Habitat for Humanity of Lafayette and the support of area churches including Northview Community Church/Lafayette and St. Andrew United Methodist Church. Volunteers join us from fraternities and sororities at Purdue along with volunteers from Vectren. Partnerships with the Crossing School of Business and Entrepreneurship, Community Ventures in Living, Area IV Agency on Aging and Henry Poor Lumber help to fund, staff and supply the SAWs mission in the area. It takes a village to build a ramp!

The Lafayette Hub now oversees and facilitates ramp building in an eight-county area including Benton, Fountain, Montgomery, Clinton, Carroll, White and Warren counties. In 2019, we completed the installation of 13 ramps in the Lafayette area and 17 ramps in the other seven counties,

ending the season with 30 ramps built in the hub which means 30 people were freed from their homes.

One of our recipients was Carlene. She is nearly 90 and while she could use a walker inside her bungalow and a scooter outside of her home, she could not get the scooter past the front door. The moment her ramp was built, Carlene was out the door on her scooter and down the street. Freedom!



Carlene had already waited years and couldn't wait a moment longer to enjoy her newfound freedom.

2020 is shaping up to be a very busy year for the Tippecanoe Hub and its spoke counties. We are seeking more volunteers and leaders for this area along with a larger facility in which to prefabricate ramp parts and store materials. Currently there are 20 individuals in the area waiting to regain their freedom. Can you help?

Why I give...

What initially drew you to SAWs? When I returned from volunteering in New Orleans in the aftermath of Hurricane Katrina, I realized I wanted to become actively engaged with a charitable organization at home. It's important for me to have hands-on involvement and SAWs is perfect for that.

What keeps you volunteering with SAWs after 10 years of service? I've seen SAWs mature from a bunch of guys getting in trucks to go build a ramp to a well-functioning organization. I was there when someone came up with the idea of pre-fabricating ramp parts which has saved countless volunteer hours over the years and enabled us to help more people. I've served on the board and have observed it getting better and better with younger people and new ideas in recent years. Volunteering with SAWs is just enjoyable to me. It has become part of my life. It's part of who I am.

What is your favorite thing about volunteering with SAWs? I enjoy helping people at the lower end of the economic spectrum who have no other options for gaining their freedom. I enjoy the camaraderie of the teams I build with. And of course, it is very satisfying to see a project from start to finish in four short hours. With SAWs you get to experience the completion of the project and see the impact it has on our recipients and their families.

Why do you support SAWs financially? I am blessed to be able to give my time, talent and treasure to support SAWs. I am blessed because I am able to do so. Giving to SAWs grows out of my faith and follows my involvement.

What difference have you seen your gifts make? More ramps have been built as more people have given to support SAWs. That means that my gifts and the gifts of others provide more people with the freedom to leave their homes. Each recipient has at least one caregiver (usually more) whose lives are also improved with the presence of a ramp.

What was your most memorable build? Building for a child is always special. The kids are always ecstatic when they can finally get out of their house and that is fun to see. It's also fun when their siblings work alongside us and participate in the build. It means a lot to the family when they can participate and it's fun for us.
